

## 2<sup>nd</sup> Workshop on Publishing Your Research in Top Finance Journals

**Bonn, May 10/11, 2019**

You are cordially invited to apply for the second workshop on improving your chances to publish your research in top finance journals. The workshop will start on Friday, May 10, 2019 with a joint lunch and conclude on Saturday, May 11, 2019 after lunch. The workshop will be held at the University of Bonn with financial support of the German Finance Association and the Excellence Cluster ECONtribute.

The workshop is targeted towards untenured faculty members to help them publish their work. The workshop will include a panel discussion on „How to improve the chances of having your research published in a very good journal“, and a group session with feedback on elevator pitches and abstracts of papers by the participants. Most importantly, each workshop participant will get two one hour one-on-one meetings with two senior scholars who have significant experience with the publishing process. - **Martin Oehmke**, Professor at London School of Economics (Associate Editor, Journal of Finance and Journal of Financial Intermediation, Member of the editorial board, Review of Economic Studies)
- **Sascha Steffen**, Professor of Finance, Frankfurt School of Finance & Management (Associate Editor, Journal of Banking and Finance).
- **Marliese Uhrig-Homburg**, Professor of Financial Engineering, Karlsruher Institut für Technologie

**Eligibility:** Candidates must be **untenured faculty members or postdocs**. Priority will be given to researchers who have received their doctorates within the last five years. The workshop is not open to doctoral students. The ideal candidate has (at least) one completed paper, possibly presented at one or more conferences, and possibly been submitted (and either been asked for a revision or been rejected) to a good journal. Preference will be given to author teams without senior faculty. If you have, please share the referee reports (both positive and negative), this will help the panelists to help you.
